

Kirkwood Intermediate (3396)

Enrolment Scheme

Commences 2 May 2022

Home Zone

All students who live within the home zone described below shall be eligible to enrol at the school.

Starting from the intersection of Riccarton Road and Waimairi Road,

- North along Waimairi Road to Maidstone Road
 - Including Kiltie Street, Reading Street, Brulay Courts, Athol Terrace
- East along Maidstone Road to Ilam Road
 - Including Farnham Place
- North along Ilam Road to Hamilton Avenue
 - Including Moorpark Place, Tuirau Place, Swanleigh Place, and Renoir Lane
- South East along Hamilton Avenue to Clyde Road
- South along Clyde Road to Kotare Street
 - Including Medbury Terrace
- East along Kotare Street to Weka Street
- North East along Weka Street to Straven Road
- North along Straven Road to Fendalton Road
- East along Fendalton Road to Deans Avenue
- South along Deans Avenue to Moorhouse Avenue
- East along Moorhouse Avenue to Lincoln Road
- South West along the North-West side only of Lincoln Road to the Christchurch Southern Motorway (SH76)
- West along the North side only of the Christchurch Southern Motorway (SH76) to Annex Road
- North West along Annex Road to Blenheim Road
 - Including Wigram Road from Annex Road to Curletts Road,
 - Including Nazareth Avenue, Magdala Place and Venture Place
- West along Blenheim Road to Hansons Lane
- North along Hansons Lane to Riccarton Road
- East along Riccarton Road to Waimairi Road

Addresses on both sides of boundary roads are considered in-zone unless specified otherwise.

Each year, applications for enrolment in the following year from in-zone students will be sought by a date that will be published by public notice in a medium appropriate to the area served by the school. This will enable the board to assess the number of places that can be made available to students who live outside the home zone.

Special Programmes

This priority category is not applicable at this school because the school does not run a Special programme approved by the Secretary.

Out of Zone Enrolments

Applications for enrolments will be processed in the order of priority specified in the [Education and Training Act 2020](#).

Before the application deadline associated with each pre-enrolment period, a Board must, by public notice in a medium appropriate to the area served by the school:

- confirm the already advertised dates for the receipt of applications and for the holding of the ballot.
- state the likely number of out of zone places that remain available.

If there are more applicants in any priority group than there are places available, selection within the priority group will be by ballot conducted in accordance with [instructions by the Secretary](#), under Schedule 20, Clause 3 (1) of the Education and Training Act 2020. Parents will be informed of the date of any ballot by public notice in a medium appropriate to the area served by the school.

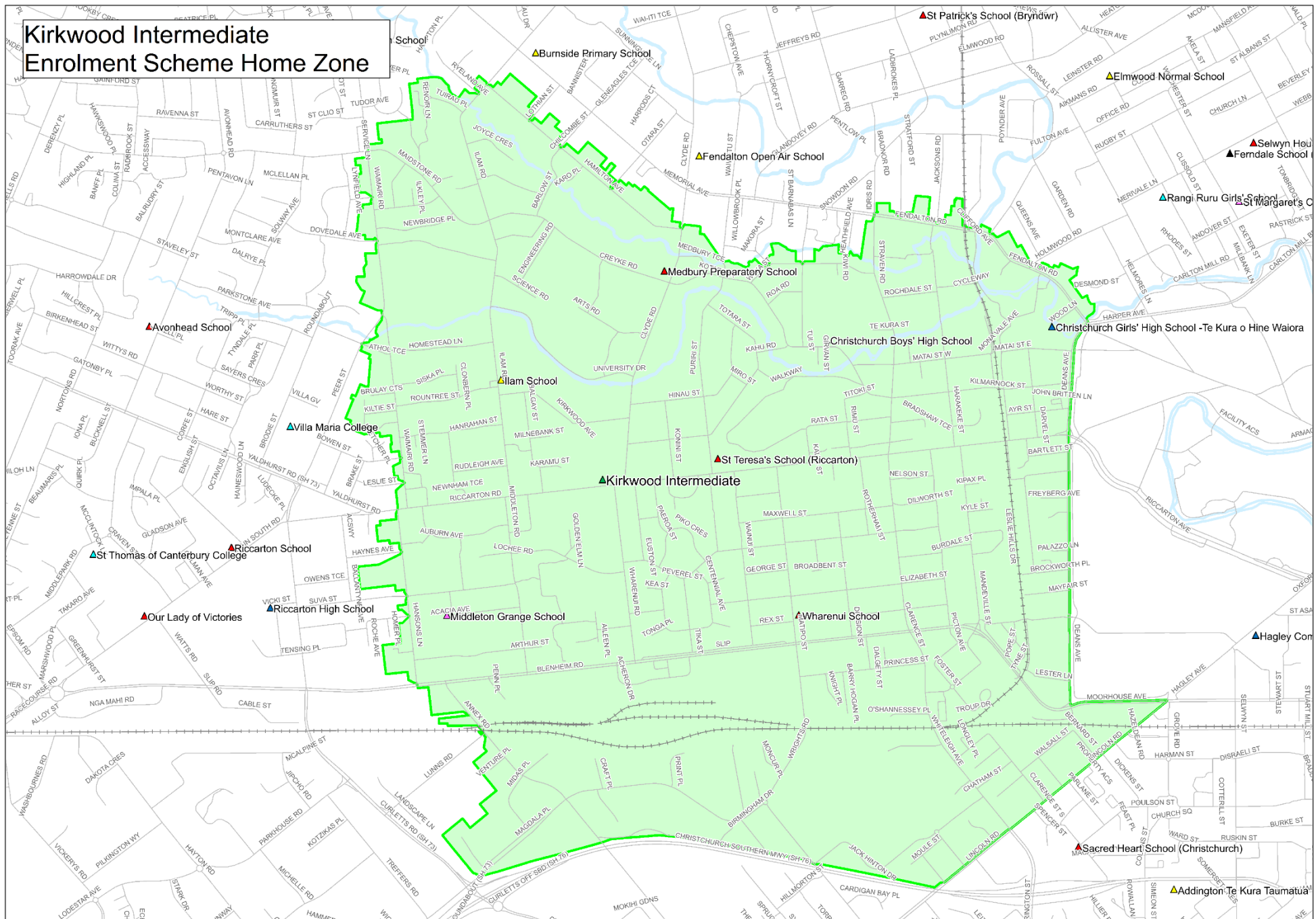
Applicants may be required to give proof of address or sibling relationship.
